

Free Token Promotion Terms and Conditions

How it Works

- The referral programme offers a two-sided reward: one for the referrer and one for the referred.
- To participate, you must provide the email address of the person that referred you
 within the Tally Market registration form. The deal will only be applied where the 100
 tokens are purchased within one month of the referred company registering on Tally
 Market.
- The referee will receive £100+VAT worth of Tally Market tokens to their account as will the referrer.
- The Tally Market promotional tokens will expire if they have not been used within one month of being applied to either of the Tally Market accounts.

Conditions

Tally Marketplace Limited ("we," "us") offers you the opportunity to earn up to £100 +VAT worth of Tally Market tokens if you (the "Company", "Companies") purchase a bundle of 100 Tally Market tokens (or more) with us. We reserve the right to terminate the Promotion ("Tally Market Office Party Promotion" or "Promotion") at any time for any reason. The Promotion is administered by Tally Marketplace Limited.

These terms ("Terms") apply to a user's participation in the Promotion. By participating in the Promotion, individuals agree to use the Promotion as outlined herein, and consistent with any other terms we may apply to the Promotion. If you do not agree to these Terms in their entirety, then you cannot register and participate in the Promotion. Individuals also cannot where in so doing, they would violate any applicable law or regulations.



Successful Referral

A referral will be a "Successful Referral" where:

A new customer provides the email address of the person that referred them within the Tally Market registration form.

A new customer is a customer that:

- (i) is not a current or previous customer of Tally Market Limited i.e. the company they work for does not have any email addresses registered on the Tally Market platform;
- (ii) is not in the same group of companies as an existing customer of Tally Market Limited;
- (v) has not been in discussions or negotiations with Tally Market regarding the receipt of our services ("New Customer"); and

Within 1 month of the New Customer's Tally Market account creation and the referral, the new customer must have purchased over £500 (or 100 tokens).

The Promotion will be awarded to Companies who meet the following conditions:

- None of our other products and services are eligible for the Promotion.
- The referred company must be a company registered in the UK on Companies House.
- Only £100 of Tally Market tokens per referred company can be awarded. This means
 that even if more than one person from a given company signed up to Tally Market
 via a referral, only £100 of Tally Market tokens will be awarded for the successful
 referral of that company.
- If several people refer the same company to Tally Market and that company starts using Tally Market, only the first person to have referred that company will get the reward.
- A person can refer as many companies as they want. There is no limit to how many rewards a person can receive.
- To refer to another company, a person needs to be a current registered user of Tally Market.
- The company you refer cannot be one you work at, operate or own.
- The referred company must not have previously registered on Tally Market prior to the referral.



- There is only one reward for each Company/organisation that is referred.
- The Tally Market promotion scheme is available to UK residents and UK registered Companies only. Entrants must be 18 plus years of age.
- In the event of any disputes regarding the Promotion, the decision of Tally Market is final. In the event of a Company not receiving a Promotion Award, a claim must be raised for consideration to finance@tallymarket.co.uk within 30 days of the office contract being signed.
